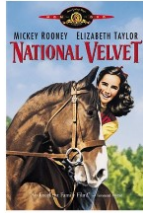

Setup will take place 2 hours before gates open each Movie Night. In case of inclement weather, Movie Nights will be rescheduled to the following Friday. There will be no refund of vendor fees.

Please complete the form below and return it with payment no later than 30 days prior to your selected Movie Night Event(s). Proof of Insurance listing the Aiken Steeplechase Association as the additional insured must accompany your application for consideration. Limited number of vendor spots available. You will be notified as soon as your application is accepted. Nonprofit organizations must provide documentation of nonprofit status with application.

REQUIREMENT FOR FOOD VENDORS: The City of Aiken Hospitality Tax Application is only for those businesses engaged in selling prepared food and beverage within the City of Aiken. The Hospitality Tax is a 1% sales tax on all prepared food and beverage that the business collects and remits back to the City of Aiken. Steeplechase Movie Nights Rules & Procedures

How to Apply

- ◆ 30 days prior to the event please mail your completed application, proof of insurance, and payment to: Aiken Steeplechase Association P.O. Box 360 Aiken, SC 29802. Only complete applications will be considered. Vendors will be notified of their acceptance within 10 days following the receipt of the application. Proof of Insurance & Rules & Procedures Agreement paperwork must accompany your application for consideration. Insurance should name the *Aiken Steeplechase Association* as the additional insured at a minimum of \$1,000,000 coverage.

Setup

- ◆ Setup begins 2 hours each Friday before gates open. You will receive more information in your ticket package once you have been accepted.

Trademark & Copyright Infringement

- ◆ Vendors are not permitted to sell any merchandise that violates trademarks or copyrights. Vendors displaying such merchandise will be asked to leave immediately and will forfeit the vendor fee. No vendor is permitted to sell merchandise with the Aiken Steeplechase logo or the words "Aiken Steeplechase" without the express prior written permission of the Aiken Steeplechase Association. A copy of this written document must accompany the vendor application.

Inclement Weather

- ◆ Steeplechase Movie Nights is an outdoor event. The event will be held the following Friday if there is inclement weather. There will be no refund of vendor fees in the case of inclement weather.

Water & Electricity

- ◆ Vendors must supply their own extension cords and their units must be properly grounded in order to plug into the electrical outlets and power panel provided. Potable water is not available.

I understand that failure to follow these rules and procedures could result in loss of participation in future Villages and ASA events.
